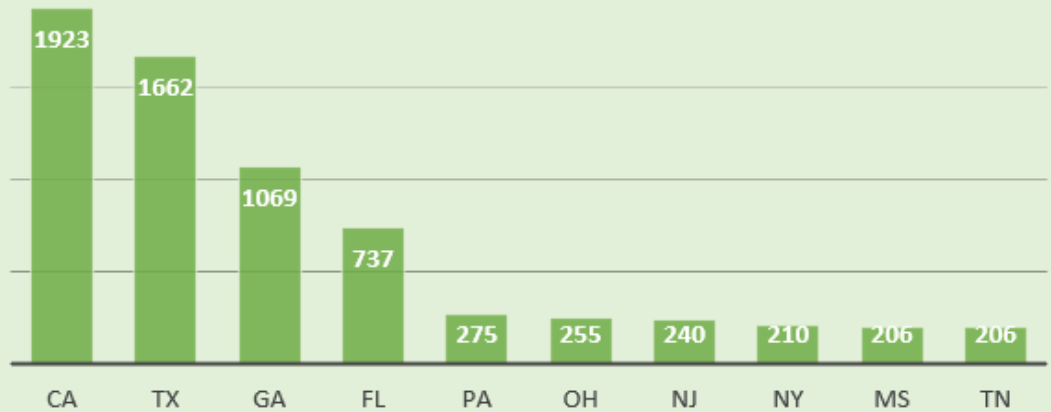

# ICSA by the Numbers

- Incorporated in Arizona September 2019 as a non-profit
- Began accepting members in March 2020
- Member accounts now at 6,426
- Over 15,000 trucks insured under ICSA's Risk Purchase Groups in 47 states
- Average Platinum Member savings on insurance = 23%
- Additional savings on fuel, tires, maintenance. MVRs, legal services, etc.
- 60% of members say they rely on ICSA publications for industry and regulatory news

# Platinum Member Requirements

As of April 20, 2023

Join ICSA and Maintain Membership in Good Standing

Log onto [www.safecarriers.org](http://www.safecarriers.org) to join ICSA and set up member profile. Maintain “good standing” status, meaning no outstanding ICSA dues, failed payments or other unpaid obligations

Activate Event Recorders; Assign Fleets Adopt Zero

Within 30 days of event recorder delivery, install event recorders, assign drivers to each and begin to utilize; authorize ICSA safety consultants to access video events

Tolerance Arrange Hair Drug Tests for All Current and Future

Carriers with more than one truck adopt and implement ICSA’s model drug and alcohol policy or similar “zero tolerance” policy upon becoming a member

Contact TADTS to schedule initial hair test(s) for current driver(s), to be performed within 90 days of joining; hair test all new driver hires prior to dispatching

Allow Access to Electronic Logging Device Data

Allow ICSA to access to each carrier’s ELD data to help safety consultants to assist the carrier with safety consulting

Govern Truck Speed to no more than 68 MPH

All trucks insured under ICSA’s program must be electronically governed at a speed of no more than 68 miles per hour to align with the proposed U.S. DOT speed limiter regulation

Meet or Exceed Minimum Safety Score

Meet or exceed a safety score prescribed by ICSA

**Members who fail to meet all requirements within the time allotted are in violation of Membership Terms & Conditions and will not qualify for continued insurance coverage under ICSA’s Risk Purchase Group.**
